Under the provisions of Education Code section 35143, your governing board is required to set an annual organizational meeting in years in which no regular election for governing board members is conducted, on any date in December, but no later than December 20, 2023. Education Code section 35143 requires the County Superintendent of Schools to designate organizational meeting is: the first Friday on December 1, 2023.
